And Whereas Part 2 Section 2.6.2. "Review of Construction" of the National Building Code requires the construction of a building falling with in the Scope of Part 4 subject to the review of a qualified person to determine compliance with the design drawings submitted to the Development and Inspection Department for the Municipality; and all revisions thereto;
