By-law No. 12. A Law to Fix the Scale of Fees to be Charged for Licences to Non Residents

Whereas by Chapter 78 45 Victoria, 1882, of the Acts of the Legislative Assembly, amended by Chapter 103 3 George VI, 1939, of the Acts of the Legislative Assembly, it is enacted that no person unless he is a resident of the Town of Woodstock or assessed therein to the value of one thousand dollars, shall engage in any trade, profession, occupation, business or calling within the limits of the said town without obtaining a licence therefor as therein provided;

And whereas by the said Act the Town Council of the said Town of Woodstock is authorized to fix the scale of fees to be charged for such licences;

Be it enacted by the Town Council of the Town of Woodstock on this 24th day of May, A.D. 1956, that the by-law to Fix the Scale of Fees to be Charged for Licences dated January 24, A.D. 1954, be repealed and the following enacted in lieu thereof:

- 1. The scale of fees tor licences to persons coming under the above mentioned Act shall be as follows:
- (a) For contractors, Master builders or mechanics employing workmen, twenty-five dollars per day, fifty dollars per week, a hundred and fifty dollars per month and two hundred dollars per year.
- (b) For journeymen mechanics in any trade and for skilled labourers, two dollars per day, ten dollars per week, fifteen dollars per month and twenty-five dollars per year.
- (c) For unskilled labourers, one dollar per day, five dollars per week, seven dollars and fifty cents per month and ten dollars per year.
- (d) For professional men, auctioneers, and sales promoters in com-petition with ratepayers, five dollars per day, twenty-five dollars per week, seventy-five dollars per month and one hundred and fifty dollars per year.
- (e) To any person to purchase in the Town for sale any farm products of the following kinds: oats, potatoes, butter, pork, hay, poultry, or grain, five dollars per day, twenty-five dollars per week, seventy -five dollars per month and one hundred and fifty dollars per year.
- (f) To any person not a commercial traveller or a farmer selling the produce of his own farm, to vend or canvass for the sale of any goods or chattels, seventy -five dollars per day, eighty dollars per week, ninety dollails per month and one hundred dollars per year.
- (g) To any person to vend or canvass for the sale of magazines, books, papers or other publications, five dollars per day, ten dollars per week, twenty dollars per month and fifty dollars per year.

- (h) To any photographer or person selling or canvassing for the sale of photographs, ten dollars per day, twenty dollars per week, fifty dollars per month or one hundred dollars per year.
- (i) To any person selling milk, cream, butter or eggs from a truck, or other vehicle, twenty-five dollars a day, seventy-five dollars a week, a hundred and fifty dollars a month and two hundred dollars a year.
- (j) For any person to vend meat, ten dollars a day, fifty dollars a week, a hundred and fifty dollars a month and two hundred dollars a year.
- (k) To any person to sell or canvass for the sale of brushes or brooms, five dollars a day, twenty-five dollars a week, seventy-five dollars a month and one hundred and fifty dollars a year.
- (l) To operate a stand for the sale of refreshments or other articles on any public street or in any public place, ten dollars per day, twenty-five dollars per-week, seventy-five dollars a month and one hundred dollars a year. To provided always that no such stand shall be erected or used without the permission in writing of the Town Council.
- (m)To any person to carry on or engage in the business of trucking for each double team one dollar per day, three dollars per week, five dollars per month and twenty dollars per year, and for single teams one half of such amount. For Motor trucks two dollars per day, six dollars per week, ten dollars per month and fifty dollars a year. Provided that the licence fee to be charged any one person in any year shall not exceed one hundred dollars.
- (n) To any circus, carnival or amusement show operating rides and side-shows, one hundred dollars per day and one hundred and twenty-five dollars a week, one hundred and seventy-five dollars a month and two hundred dollars a year.
- (o) To engage in or carry on any trade, profession, occupation, business or calling not herein specified, five dollars per day, twenty dollars per week, fifty dollars per month and one hundred dollars per year.
- 2. This by-law shall not apply to any farmer selling or canvassing for the sale of produce of his own farm.
- 3. Any person carrying on any trade, profession, occupation business or calling within the Town without first securing a licence so to do, unless he is a resident of the Town or assessed therein to the value of one thousand dollars shall be liable to a fine not exceeding one hundred dollars and in default of payment be imprisoned in the common Gaol for any period not exceeding thirty days.
