By-law No. 15. A Law to Regulate and Compel the Removal of Snow and Ice

Be it enacted by the Town Council of the Town of Woodstock this 25th day of January A.D. 1954, as follows:

The by-law entitled "A Law to Regulate and Compel the Removal of Snow and Icicles," passed on May 6, 1922, and the amendments thereto, are hereby repealed and the following is enacted in lieu thereof:

- 1. The owners or occupiers of any business or commercial property fronting on any street shall, whether the snow plow shall have passed their premises or not, remove or cause to be removed all snow or ice remaining or being on the sidewalks in front of their premises, and also, where the snow plow has passed, the snow ridge left thereby, to the width on Main Street of twelve feet, and on any other street to the width of the sidewalk, the same to be removed before ten o'clock in the morning following the ceasing of any snowstorm or the passing of the snow plow if such occur after business hours; otherwise immediately after the ceasing of such storm or the passing of such snow plow.
- 2. Any person neglecting to comply with any of the provisions of Section 1 shall be liable to a penalty of \$2.00 for the first day of such neglect, or any part of the first day, and an additional penalty of \$2.00 per day or part of day during each subsequent day on which such neglect is continued.
- 3. All snow and ice removed from the sidewalks and also the snow ridge left by the snow plow shall be placed in a pile on the edge of the street and off the sidewalk. For any breach of this section the offender shall be liable to a penalty of \$2.00 for each day or part thereof on which such breach shall be made or shall continue.
- 4. When persons occupy or use an alleyway or private way in common, that portion of the sidewalk opposite such alleyway shall be cleared and the snow removed as herein after required by the said parties equally.
- 5. All snow or ice hauled or removed from private yards or premises or from the roofs of buildings shall not be put, placed or left in or on any public street, highway or "sidewalk, but shall be hauled away to the River Saint John or the Meduxnekeag stream, or some open plot of ground, and there disposed of as the Town Manager shall direct, in such a manner as not to interfere with any public or private road, sidewalk or passage way, under a penalty of \$2.00 for each offence against this section.

| 6. | The owners of buildings fronting or abutting on any public street shall keep the roof and eaves thereof free from snow, ice and icicles, so that the same shall not be dangerous to persons passing upon or along such streets, or into or out of such buildings, under a penalty of \$5.00 for each offence under this section. |

By-Law No. 15 A Law to Regulate and Compel the Removal of Snow, Ice, and Dirt

Be it enacted by the Town Council of the Town of Woodstock on this 25th day of February, A.D. 1974j, as follows.

The By-Law entitled a taw to regulate and compel the removal of snow and ice enacted on January 25, A.D. 1954, is repealed and the following is enacted in lieu thereof;

1. The owners or occupants of any business, commercial or public property in the Town of Woodstock shall remove or cause to be removed all snow or ice remaining or being on the sidewalks fronting or bounding their premises or from private exits or passageways from their premises to the street, such snow or ice to be removed before the hour of ten o'clock in the forenoon of each day of the week excluding Sundays and Holidays. Reasonable snow and ice removal is to be continued and carried on during business hours. Any business, bank, or office shall be responsible for such removal of snow and ice on any day or evening on which they are closed during the hours when retail stores normally remain open, such as Friday evenings, Saturdays, and evenings on which the majority of retail stores remain open prior to Christmas.

Salting is to be done when necessary and salting and removal of snow and ice continued until the sidewalks are bare.

At such times as the sidewalks are bare throughout the year they shall be swept clear on sand, gravel, dirt, and rubbish. Sand, dust, and gravel may be swept into the ditch. Papers, bottles, cans, and other rubbish shall be placed in garbage receptacles or otherwise removed.

- 2. Any person refusing or neglecting to comply with any of the provisions of Section 1 shall be liable to a penalty of not less than \$10.00 for each day or part of such day of such neglect or refusal.
- 3. All ice and snow removed from the sidewalks and also the snow ridge left by the snow plow shall be placed in a pile on the edge of the street and off the sidewalk. For any breach of this section the offender shall be liable to a penalty of not less than \$10.00 for each day or part thereof on which such breach shall be made or shall continue.

A small path shall be cleared through the snow so pilled to permit the passage of pedestrians.

- 4. When persons use an alleyway or private way in common that portion of the sidewalk opposite such alleyway or private way shall be cleared and the snow removed as hereinafter required by such persons equally.
- 5. All snow or ice hauled or removed from private yards or premises or from the roofs of buildings shall not be put, placed, or left on any public street, highway, or sidewalk, but shall be hauled away to the River Saint John or the Meduxnekeag River, or some open plot of ground, and there disposed of as the Town Manager shall direct in such a manner as not

- to interfere with any public or private road, sidewalk, or passage way, under a penalty of not less than \$10.00 for each offence against this section.
- 6. The owners of buildings fronting or abutting on any public street shall keep the roof and eaves thereof free from snow, ice, and icicles, so that the same shall not be dangerous to persons passing upon or along such street, or into, or out of such buildings, under a penalty of not less than \$10.00 for each offence under this Section.
- 7. For any infringement against this By-Law for which no specific penalty is provided the offender shall be liable to a fine of not less than \$10.00.

Be it enacted by the Town Council of the Town of Woodstock on this 25th day of February, A.D. 1974, as follows:

The By-Law entitled a Law to regulate and compel the removal of snow and ice enacted on January 25, A.D. 1954, is repealed and the following is enacted in lieu thereof:

1. The owners or occupants of any business, commercial or public property in the Town of Woodstock shall remove or cause to be removed all snow or ice remaining or being on the sidewalks fronting or bounding their premises or from private exits or passageways from their premises to the street, such snow or ice to be removed before the hour of ten o'clock in the forenoon of each day of the week excluding Sundays and holidays. Reasonable snow and ice removal is to be continued and carried on during business hours. Any business, bank or office shall be responsible for such removal of snow and ice on any day or evening on which they are closed during the hours when retail stores normally remain open, such as Friday evenings, Saturdays and evenings on which the majority of retail stores remain open prior to Christmas.

Salting is to be done when necessary and salting and removal of snow and ice continued until the sidewalks are bare.

At such times as the sidewalks are bare throughout the year they shall be swept clear of sand, gravel, dirt and rubbish. Sand, dust and gravel may be swept into the ditch. Papers, bottles, cans and other rubbish shall be placed in garbage receptacles or otherwise removed.

- 2. Any person refusing or neglecting to comply with any of the pro-visions of Section 1 shall be liable to a penalty of not less than \$10.00 for each day or part of such day of such neglect or refusal.
- 3. All ice and snow removed from the sidewalks and also the snow ridge left by the snow plow shall be placed in a pile on the edge of the street and off the sidewalk. For any breach of this section the offender shall be liable to a penalty of not less than \$10.00 for each day or part thereof on which such breach shall be made or shall continue.

A small path shall be cleared through the snow so piled to permit the passage of pedestrians.

4. When persons use an alleyway or private way in common that portion of the sidewalk opposite such alleyway or private way shall be cleared and the snow removed as hereinafter required by such persons equally.

- 5. All snow or ice hauled or removed from private yards or premises or from the roofs of buildings shall not be put, placed or left on any public street, highway or sidewalk, but shall be hauled away to the River Saint John or the Meduxnekeag River, or some open plot of ground, and there disposed of as the Town Manager shall direct in such a manner as not to interfere with any public or private road, sidewalk or passage way, under a penalty of not less than \$10.00 for each offence against this section.
- 6. The owners of buildings fronting or abutting on any public street shall keep the roof and eaves thereof free from snow, ice and icicles, so that the same shall not be dangerous to persons passing upon or along such street, or into or out of such buildings, under a penalty of not less than \$10.00 for each offence under this section.
- 7. For any infringement against this By-law for which no specific penalty is provided the offender shall be liable to a fine of not less than \$10.00.

Any person neglecting to comply with any of the provisions of Section I shall be liable to a penalty of \$2.00 !or the first day of such neglect, or any part of the first day, and an additional penalty of \$2.00 per day or part of day during each subsequent day on which such neglect is continued.
- 3. All snow and ice removed from the sidewalks and also the snow ridge left by the snow plow shall be placed in a pile on the edge of the street and off the sidewalk. For any breach of this section the offender shall be liable to a penalty of \$2.00 for each day or part thereof on which such breach shall be made or shall continue.
- 4. When persons occupy or use an alleyway or private way in common, that portion of the sidewalk opposite such alleyway shall be cleared and the snow removed as hereinafter required by the said parties equally.
- 5. All snow or ice hauled or removed from private yards or premises or from the roofs of buildings shall not be put, placed or left in or on any public street, highway or sidewalk, but shall be hauled away to the River Saint John or the Meduxnakeag Stream, or some open plot of ground, and there disposed of as the town manager shall direct, in such a manner as not to interfere with any public or private road, sidewalk or passage way, under a penalty of \$2.00 for each offence against this section.

The owners of buildings fronting or abutting on any public street shall keep the roof and eaves thereof free from snow, ice, and icicles, so that the same shall not be dangerous to persons passing upon or along such streets, or into or out of such buildings, under a penalty of \$3.00 for each offence under this section. | | |

Section 3 of the said By-Law is amended to striking out the words "\$2.00" in line 4 thereof and substituting in lieu thereof the words "\$10.00".
