The levy shall be in the amount of \$22,657 at the rate of \$0.15 / \$100 of Assessment and the Council hereby directs and orders the Minister of Environment and Local Government of levy the said amount pursuant to provisions of the Business Improvement Area Act.. Public Presentation 809 Main Street – PID 10108066

CAO Harding distributed a map of the proposed rezoning. The process for rezoning 809 Main Street was reviewed. The public has 30 days to respond in writing to this proposed rezoning.

2017 General Utility and Capital Fund Budgets

The General and Utility Budget was presented by CAO Harding and Councillor Sutherland.

General Fund:

Councillor Sutherland noted that there would be a 1 cent property tax increase for 2017. The last increase was 9 years ago.

Utility Fund

In reviewing the Utility budget Councillor Sutherland highlighted the need to increase the revenue for the water rates by 6 percent and the sewer rates by 8 percent. The increase for

water rates is necessary to fund the exploration of the second water source and the sewer increase is required in order to fund expenditure increases.

CAO Harding commented on the general and utility budgets and announced that there would be a consulting expense in 2017 in order to recruit a replacement CAO for the Town of Woodstock since CAO Harding will be retiring in June of 2017.

MOTION: The Municipality of Woodstock RESOLVES that the sum of \$9,540,688 be the total operating budget of the Municipality, that the sum of \$7,219,555 be the Warrant of the Municipality for the ensuing year, and that the tax rates for the Municipality be \$1.43 (Inside), \$1.38 (Outside) and \$1.38 (Industrial Park). The Council orders and directs the levying by the Minister of Environment and Local Government of said amount of real property liable to taxation under the Assessment Act within the Municipality of Woodstock. Councilor Sutherland, Councillor Blackburn.

MOTION: The Municipality of Woodstock RESOLVES that pursuant to paragraph 189(4) of the Municipalities Act, the total budget for the Water / Sewer Utility for the ensuing year would consist of total revenues of \$1,365,769, and total expenditures of \$1,365,769. Councillor Sutherland, Councillor Bradbury.
